**COURT REPORTER'S  
VERIFIED MOTION FOR EXTENSION OF TIME  
TO FILE TRANSCRIPT**

Barbara Ruwe, The Court Reporter of Dearborn Superior Court II, respectfully petitions the Court for an extension of time in which to file the transcript in this appeal. In support of this Motion, the court reporter shows the Court as follows:

1. The Appellant filed a Notice of Appeal on October 24, 2012. At that time Mr. Jeff Stratman was appointed as appellate counsel and through verbal discussion with him, he only requested a transcript of the jury trial and the sentencing hearing.
2. On or about December 28, 2011, I received a phone call from [REDACTED] indicating they would be filing an entry of appearance. At that time, I indicated to him that I would need a deposit as soon as possible and that upon completion of the transcript, the balance would have to be paid prior to filing of that transcript. I also indicated to him that Mr. Stratman had only requested a transcript of the jury trial and sentencing hearing.
3. On January 18, 2012, an appearance was filed by [REDACTED] a deposit for the transcript was received.
4. On January 20, 2012, a fax was sent to [REDACTED] office indicating that the transcript was complete and a bill for the remainder due.
5. On January 23, 2012, I was prepared to file the transcript of the jury trial and the sentencing hearing but had not received the balance due for the transcript.

6. On January 24, 2012, I received a call from [REDACTED] indicating that they were requesting additional hearings to be transcribed. I requested that he follow up in writing which I received a letter and have attached to this motion. In his letter he is requesting that I not file the completed portions of the transcript until the additional portions are complete.

WHEREFORE, Barbara Ruwe, court reporter for Dearborn Superior Court II respectfully requests an extension of time of ninety (90) days to complete the transcript for the additional hearings requested.
